

TERMS & CONDITIONS/SAFETY AND COMPLIANCE

Responsibilities of Renters and Driving Restrictions:

As overland adventurers ourselves, we do realize that driving conditions and roads can be unpredictable at times. While our fleet comes properly equipped, we advise you to use your best judgment and only travel in driving conditions that do not exceed the capability of the driver and vehicle. We are confident you will treat our Adventure Rigs and/or Adventure Wagons like they're your own and that you would protect the vehicle against inclement weather and other road hazards.

- Our vehicles and trailers, as outfitted, are designed to not exceed the GVWR as directed by the manufacture's specifications. Due to vehicle weight safety limitations, it is the Renter's responsibility to verify that the combined total weight of all occupants, occupants' personal items, occupants' food and drink (or any other items the occupant deems necessary for travel and overnight(s) trip) must not exceed the GVWR as specified by the manufacture. If unsure please notify Idaho Overland Adventures LLC. Idaho Overland Adventures LLC reserves the right to not accept passengers and luggage that exceed our vehicles operating weight limitations. We may decide, at any time, to exclude any person or group, or items for any reason we feel is related to the safety of our renters and services.
- Due to the spirit of our camping with ease concept, specifically in regards to the roof-top tent with ladder, any families traveling with small children, or any occupants that are unable to access the roof top tent by way of provided ladder will have the option of a ground tent, or annex.

You, as the Renter understand and agree that you, are solely responsible for compliance with any and all laws, rules, regulations, and tax obligations that may apply to your use of our vehicle/trailer and must agree to the following:

- **PROHIBITED USE OF THE VEHICLE VIOLATES THIS AGREEMENT AND VOIDS ALL LIABILITY AND OTHER INSURANCE COVERAGE.**
- Allowing a person who is not an Authorized Driver to use the Vehicle or Trailer is not an exercise of ordinary care, but a willful, and reckless act and is a breach of this agreement.
- Children must be transported in proper child safety seats required by law.
- Pets permitted only with prior written request by Renter and approval by Idaho Overland Adventures LLC ,and with addition fee. Pets must be restrained or crated during transport.
- Our rentals may be used on authorized, unsealed dirt roads; however they are not intended to be used for "rock-crawling", heavy-duty trail exploration, use in non-designated off-road areas, on closed roads, or private property, or any areas that exceed the vehicle/trailer limitations. If you travel in a restricted area you will be liable for all fines, damages to vehicle/trailer, tires, windshield, additional equipment, and towing/recovery charges, along with any additional expenses resulting from breakdown or accident. Furthermore, our vehicles cannot be used in any race, speed test, or contest. Such use of our vehicles in these applications and settings is strictly off limits. (see "Payments and Charges")
- You may NOT violate any local, state, provincial, federal, national, park, campground or other law or regulation.

- The consumption of alcohol, controlled substances, or intoxicants while operating any vehicle is strictly prohibited. In addition, carrying any type of illegal substance in or on our vehicles is also prohibited.
- At no point during the rental period may the vehicle be driven or taken outside the United States.
- Our Adventure Rigs are NOT allowed to have anything towed behind them.

Supplied Water and Refrigerator Notifications:

- On-board each of our rentals, we have supplied you with enough **POTABLE WATER**, intended for hand and dish washing purposes.
- Water supplied is intended to last **48 hrs** (a typical two night rental) for up to four people if managed appropriately and responsibly.
- The on-board Fridge, when properly supplied and packed, will fit enough cold food to last up to four people up to **48 hrs**.
- It is your responsibility to refill your water tank and restock your cold food supply if you are on an extended trip.

MEDICAL CONDITIONS AND SPECIAL REQUIREMENTS:

Under most circumstances, if you are in good health and have an adventurous spirit, then you should have no problem enjoying our services we have to offer. However, it is your responsibility, as the Renter, to notify us in writing during the process of booking of any medical conditions, pregnancy, disability or any other mental or physical condition which may affect your ability to enjoy your Adventure Rig/Adventure Trailer rental with Idaho Overland Adventures LLC. Failure to notify us of any such condition that may generate the cancellation or refusal of your rental package could result in the complete loss of all fees paid for the package with no refunds. Our rentals may be unsuitable for some individuals due to age, mobility, physical stature, disability, pregnancy, physical or mental conditions. It is the responsibility of the potential Renter to consult a licensed physician prior to booking. We are not required to provide any special facilities unless we have agreed to do so in writing, prior to time of rental. We will do our best to meet any special requests, but such requests do not form part of the Contract and therefore Idaho Overland Adventures LLC will not be held liable for not providing or complying with these requests.

We recommend following all CDC recommend guidelines and advisories. We commit to do the same when cleaning and sanitizing our vehicles, trailers and equipment after each use.

CHANGES AND MODIFICATIONS:

Changes made Idaho Overland Adventures LLC: Idaho Overland Adventures LLC reserves the right to change any of the facilities, services or prices described on the website and brochure before a booking is made. If such a change is made, the Renter will be told at the time of booking or when the change occurs. If Idaho Overland Adventures LLC makes a major change, we will inform the Renter as soon as reasonably possible if there is time before departure. The definition of a major change is deemed to be a change affecting at least one day of scheduled rental period. When a major change is made, the Renter may choose between accepting the change, obtaining a full refund of all the money paid or accepting a prorated refund deemed acceptable by Idaho Overland Adventures LLC.

Changes made by the Renter: The Renter may only change a booking departure and/or return dates, prior to 7 days in advance of original pick-up date, and only if reservations are available. Within 7 days of original pick-up date, any such changes may be regarded as a cancellation and cancellation fees may apply. To extend the rental period, you may be required to return the Vehicle to our rental office for another inspection. A "Rental Agreement Amendment" will be completed by Idaho Overland Adventures LLC. This amendment will then constitute the entire agreement between you and us.

You agree, as the Renter and individuals that accompany the renter, during your adventure, images, photos or videos may be taken by other travelers and/or the Company Staff that may contain the Renter, or persons in their company, in part or in whole. The Renter agrees that these images may be reproduced by the Company and the Renter grants perpetual, royalty-free, worldwide, irrevocable license to reproduce such images, photos or video in any medium for promotion and publicity purposes.
